## OUR grantmaking IMPACT

Alaska Conservation Foundation serves as the only public foundation solely dedicated to protecting Alaska's natural environment and the ways of life it sustains. Since 1980, ACF has performed a vital role in preserving some of the last truly intact, wild and healthy ecosystems in our nation by providing strategic and financial support to our nonprofit partners working toward our shared goals. Through

our grantmaking, we encourage broad-based support for and innovative solutions to Alaska's most pressing conservation issues in pursuit of a healthy environment, healthy communities and sustainable economies. In fiscal year 2014, ACF awarded 89 grants totaling more than \$2.75 million to support conservation efforts statewide.

#### SUPPORTING INDIGENOUS CONSERVATION EFFORTS

Alaska Natives have a profound reliance on the environment to maintain their traditional values and ways of life. Unfortunately, climate change and unsustainable development continue to threaten the resources they depend upon for their livelihood and food security. Despite their responsible stewardship of the land, Alaska Native communities have historically received just a fraction of philanthropic support for their conservation work. In fiscal year 2014, ACF continued to partner closely with an Alaska Native Steering Committee through the Alaska Native Fund grantmaking program to support projects that address the critical conservation issues affecting their cultures, communities and economic opportunities. **ACF awarded more than \$184,000 in grants to support this effort.** 

#### **BUILDING CONSERVATION CAPACITY**

ACF's Community Capacity initiative is an effort to strengthen Alaska's conservation organizations and leaders to achieve even greater conservation impact. In fiscal year 2014, ACF continued to focus its strategic and financial support on efforts to ensure citizens have a voice in the democratic process as it relates to resource management decisions. Grants also included Organizational Capacity grants which build the capacity of grassroots conservation organizations, and Rapid Response grants designed to quickly address unforeseen threats to Alaska's wild lands, clean waters and wildlife of statewide or national significance. **ACF awarded over \$218,000 in grants to support these efforts.**

#### **INSPIRING THE NEXT GENERATION**

Preserving Alaska's future depends on developing the next generation of conservation leaders. ACF's popular Ted Smith Conservation Internship Program is a strategic investment in young adults who plan a career path in conservation and are eager to make a long-term commitment to preserving and protecting Alaska. In fiscal year 2014, ACF partnered with Alaska Center for the Environment to again offer students from Alaska and around the country valuable conservation work experience at partner organizations throughout the state. **ACF awarded over \$50,000 in grants to support 10 internships across Alaska**.

#### **DEFENDING BRISTOL BAY**

The Bristol Bay region in Southwest Alaska is defined by salmon; its half-million square miles of rivers and streams sustain the largest remaining wild salmon populations on Earth. Meanwhile, the proposed Pebble Mine—slated to be the largest open-pit mine in North America—threatens the health of the entire ecosystem. In fiscal year 2014, ACF continued to provide leadership and financial support to the Bristol Bay Protection Campaign—a diverse coalition working to safeguard this unparalleled watershed and the sustainable economy of fishing, tourism and subsistence it supports. **ACF awarded \$75,000 in grants to support this effort.** 

#### MITIGATING CLIMATE CHANGE

Alaska is experiencing the effects of rapid climate change more than any other state. Meanwhile, over five trillion tons of coal resources (1/8 of the world's total) lie under Alaska's wild lands, and many coal-related projects have been proposed to mine it. In fiscal year 2014, ACF continued to support the Alaskans for Energy Freedom Campaign—a diverse coalition working to keep this coal in the ground and prevent the impacts that developing it will have on the Earth's climate, as well as on Alaska's lands, waters and people. **ACF awarded over \$1.5 million in grants to support this effort.** 

#### **PROTECTING THE TONGASS**

The Tongass National Forest in Southeast Alaska is the world's largest remaining coastal temperate rainforest. More than half of it has been compromised from decades of clear-cutting. In fiscal year 2014, ACF continued to provide leadership and financial support to the Tongass Fish People & Place Campaign—a diverse alliance working to protect critical watersheds, promote forest management policies that engage local communities in forest planning and support sustainable economic activities that depend on living resources. **ACF awarded more than \$600,000 in grants to support this effort.** 





#### MOBILIZING ALASKANS TO PROTECT OUR CLEAN WATERS

Last fiscal year, during the second session of Alaska's 28th Legislature, Alaska Governor Sean Parnell aggressively sought passage of House Bill 77-a bill that would have been devastating for Alaska's clean waters and wild salmon. It would have removed Alaskans from the public comment process on many resource extraction permitting decisions and given developers proposing massive mining projects—like the proposed Pebble Mine in Bristol Bay—unlimited access to the water they need for development.

In response, ACF deployed Rapid Response grants to long-time, trusted grantees Alaska Center for the Environment and Alaska Conservation Voters to support their efforts to organize Alaskans around this issue. The investment paid big returns for Alaska's clean waters and wild salmon as citizens turned out in force to voice their concerns. As the Legislature wound to a close in April 2014, in spite of Governor Parnell's aggressive attempts to seek passage of HB77—it failed. #### **BUILDING CAPACITY TO BETTER PROTECT THE TONGASS**

The Tongass rainforest in Southeast Alaska is home to the largest remaining stands of coastal temperate rainforest in the world, yet timber corporations have logged almost 1,000,000 acres of these ecologically rich forests. Now, less than half of the biggest and best old-growth trees are left. Communities in the Tongass have evolved around the rich marine resources, salmon, minerals and timber that make this area iconic and at times in its history, very prosperous. More recently the region has experienced protracted economic and social decline as a result of having an economy built primarily on boom and bust cycles related to logging and mining.

Long-time grantee Sitka Conservation Society is working in earnest to turn this tide in an effort to fulfill their mission to protect the Tongass and simultaneously develop economically, socially and environmentally sustainable communities within it. This is why in fiscal year 2014, ACF awarded SCS an Organizational Capacity grant to help them achieve their goals to become even more effective at what they do, which will ultimately translate to greater efforts to protect the Tongass. #### INCREASING FOOD SECURITY BY REDUCING SALMON BYCATCH

As the mighty Yukon River flows from Canada through the heart of Alaska to the Bering Sea, it supports the longest wild Chinook salmon migration in the world. These Chinook salmon have sustained the cultural and nutritional needs of the 42 predominantly Alaska Native communities along the river for millennia—however this critical resource is in great decline, and in recent years even subsistence fisheries have been closed. One of the contributors to mortality is the destructive industrial-scale Bering Sea pollock fishery which catches and discards significant amounts of salmon, preventing them from returning to their spawning grounds along the Yukon River.

In FY2014, ACF awarded Yukon River Drainage Fisheries Association an Alaska Native Fund grant. YRDFA is a non-profit association of subsistence and commercial Alaska Native fishermen who work tirelessly to protect and maintain healthy fisheries and cultures along the Yukon River. This grant allowed YRDFA to continue their advocacy in reducing wild salmon bycatch in the Bering Sea in an effort to enhance food security for the people on the Yukon. 


