Bring VERY warm clothing, binoculars, spotting scopes, lunch, snacks, and lawn chairs and sit back while you watch migrating raptors glide over the nearby ridge. The weather can vary from sunny and reasonably warm to brutal chilling cold, so be prepared for anything. Meet at 10am at the Milepost 118.8 pullout on the Glenn Highway. A short raptor identification talk by Bob Dittrick will take place at 10:30am. On Sunday, the Mat-Su Birders will host their annual Hawk Watch Potluck BBQ at the same location.
