The proposed riverbank and non-motorized boat launch improvements are anticipated to place fill in the regulated floodway of the Special Flood Hazard Area Zone AE of the Chena River floodplain. possible that another developer could take over. When uranium is extracted from the ground as ore, it undergoes a process that utilizes multiple chemicals and blasting, resulting in significant quantities of mine tailings and polluted wastewater that will continue to contaminate for years to come. PRINCE of WALES Comments are due DRAFT FOREST LAND USE PLAN for the ODYSSEY/EXCHANGE COVE TIMBER SALE. The sale area is found within the Petersburg A-4 USGS quadrangle. The main access for this sale area is from the existing Prince of Wales Road System. The harvest units total approximately 107 acres and contain approximately 2,200 MBF of timber. This volume was already sold under the provisions of AS 38.05.118 to Viking Lumber Company Inc. The FLUP is intended to provide the best available information regarding the proposed timber harvest on 107 acres and the management of other non-timber uses in compliance with AS 38.05.112 and AS 41.17.060 and must be adopted by the DoF before the proposed activity can occur. This FLUP does not determine whether or not to access and sell timber within the timber sale area, nor the method of sale. Those decisions have been made previously in the March 7, 2025, Best Interest Finding and are not appealable under this FLUP. The public is invited to comment on the FLUP. TOK/COPPER RIVER AREA - Comments are due on the proposal to adopt a SITE-SPECIFIC FOREST LAND USE PLAN (FLUP). This timber sale is in the Tanana Valley State Forest approximately 12 miles southwest of the community of Tok. Access to the sale area is along the Tok Cutoff Highway near Mile Marker 112. The eight harvest units

total 343 acres and contain approximately 5300 CCF of spruce sawtimber and approximately 2000 CCF of fuelwood in the form of spruce, poplar, and some aspen. This volume will be sold under the provisions of AS 38.05.115, in the form of one or multiple sales. The FLUP is intended to provide the best available information regarding the proposed timber harvest on 343 acres, and the management of other non-timber uses and must be adopted by the DOF before the proposed activity can occur. This FLUP does not determine whether or not to access and sell timber within the timber sale area, nor the method of sale. MVP is governed by a seven-member Policy Board composed of elected and appointed officials from the Matanuska-Susitna Borough, the Cities of Palmer and Wasilla, Knik Tribe, Chickaloon Native Village, and the Alaska Department of Transportation & Public Facilities. MVP is responsible for developing transportation plans and policies, setting priorities for the use of federal transportation funds. and providing a collaborative forum for regional decision-making. The Public Participation Plan (PPP) provides the framework for MVP's continuous, cooperative, and comprehensive (3C) transportation planning process. It outlines how MVP will keep the public informed, engaged, and involved throughout transportation planning efforts and the infrastructure projects that follow. ### September 30

Comments are due on the DoF RESUMPTION of PUBLIC SCOPING of HAINES STATE FOREST RMA MANAGEMENT PLAN after a hiatus in public planning activities since December 2024. Initial HSF RMA MP public amendment activities began in Spring 2024 with scoping meetings, online surveys, and an informational meeting in October 2024. During this initial scoping phase, the amendment was framed with the primary focus of inserting language to allow carbon offset projects as a potential use of the forest resources. After reflecting on the DOF's resource management goals within the HSF RMA and upon the Department of Natural Resources (DNR) goals to provide opportunities for carbon offset projects within Alaska's State Forest lands, the DOF has determined that additional changes to the management policy within the HSF RMA MP are necessary to best support these goals. These additional changes include the following: 1. Policy language will be written to allow forest management including timber harvest and carbon

offset projects on all land classifications within the HSF RMA. 2. Management intent for each unit will be amended from broadly defining a unit's management intent by a single resource use to defining management intent for multiple resources present on the landscape. With these adjustments to the amendment goals, the DoF would like to offer additional opportunities for the public to provide input on policy development prior to the public review of the amended HSF RMA MP draft. Four public scoping surveys and an interactive web map have been re-opened for public input through September 30. Request for Public Comment: National Plan for Arctic Research The Interagency Arctic Research Policy Committee (IARPC), chaired by the National Science Foundation, seeks public input from all interested parties on national needs regarding the Arctic and the research necessary to address those needs. ## ITEMS of INTEREST

\*\*The ANNUAL STATE of the CLIMATE REPORT provides a comprehensive overview of global conditions in 2024. University of Alaska Fairbanks Rick Thoman was the lead editor of the Arctic Chapter this year, and several other UAF scientists authored sections of the report. Their contributions demonstrate that increasing air, ocean and ground temperatures; greater precipitation; and declining snow and sea ice cover are transforming Alaska and the Arctic. 2024 was the second-warmest year on record (since 1900) in the Arctic. Deadhorse reached 89 degrees Fahrenheit on Aug. 6, 2024, the highest temperature ever recorded in Alaska north of 70 degrees latitude. 2024 experienced the third-highest average precipitation (since 1950) in the Arctic and the highest summer (July-September) precipitation. Permafrost temperatures rose again after several years of slight cooling. 2024 marked the highest temperature ever recorded at a few sites. Satellite observations of plant color show that vegetation across the North American Arctic was the greenest ever observed (since 2000). And Alaska's North Slope was much greener than average. This trend is primarily driven by warmer summers, which make vegetation more productive. Greening is also associated with the expansion of shrubs into areas where small tundra plants once dominated. Documenting these occurrences annually makes the State of the Climate a key resource for understanding and tracking climate change globally and in Alaska. The State of the Climate is a supplement to the Bulletin of the American Meteorological Society and has been produced since 1996. ALASKA MARINE DEBRIS ACTION PLAN including insights provided through in-person and online listening sessions, are community-built frameworks to identify and capture a

picture of the marine debris issue in a specific region or state. This includes an understanding of what is already being done, the gaps and challenges, and the priority actions to address those gaps and challenges. The Alaska Marine Debris Action Plan is unique in that it captures these elements while also providing context on how the marine debris issue, and the actions needed to address it, are unique in Alaska.
